Indemnification: Applicant agrees to indemnify and save harmless Pinellas County, its Board of County Commissioners, office and employees from and against all loss or expense (including costs and attorney's fees) by reason of liability imposed by law upon Pinellas County for damages (including any strict or statutory liability and any liability under Workers' Compensation Laws) because of bodily injury including death, sustained by any person or persons, or damage to property, including loss of use thereof, arising out of or in consequence of the use of the premises, whether such injuries to persons or damage to property is due or claimed to be due to the negligence of APPLICANT, its agents, employees, and subcontractors, Pinellas County, its' Board of County Commissioners officers and employees, except only such injury or damage as shall have been occasioned by the sole negligence of Pinellas County.
- C. Observance of Laws: Applicant agrees to observe , comply with and execute promptly at its expense during the term herein all laws, rules, requirements, orders, directives, codes, ordinances and regulations of any and all governmental authorities or agencies, all municipal departments, bureaus, boards and officials and of insurance carriers, due to the use or occupancy of the county premises described herein.
- D. Permit Application: This application must be submitted, approved and executed or approved copy must be made available to APPLICANT prior to commencement of production.
- E. Coordination with County Department: APPLICANT shall coordinate all production activities with the county department affected by said production. No production shall commence without signed approval by the affected department head.
- F. County Employees: If the use of county employees is necessitated, as determined by affected department heads, any overtime expenses incurred will be reimbursed to the county general fund by the APPLICANT. All expenses incurred will be provided by invoice APPLICANT.
- G. Pinellas County requests location credit on all written publications and on appropriate video programming.
